

Roster of Certified Spanish Language Court Interpreters

Certification is the highest level court interpreter in the Mississippi Judicial system. To become a Certified Court Interpreter in Mississippi, an interpreter must already be a Registered Court Interpreter and additionally must pass the National Center of State Court Oral Certification Examination. A Certified Court Interpreter has tested skills in simultaneous and consecutive court interpreting as well as in sight translation and has scored at least a 70% one each testing session.
