Application to Practice Court Reporting in the State of Mississippi: Certification as a Certified Shorthand Reporter, Temporary Permission as a Noncertified Court Reporter, or Temporary Permission as a Nonresident Court Reporter

INSTRUCTIONS:

1. Read Sections 9-13-101, et seq. (enclosed)
2. Fill out the application form. **NOTE:** All **completed** applications must be received 10 business days prior to the BCCR Board Meeting. (See website for a list of dates)
3. Sign before a notary.
4. Enclose a short letter stating why the Board should consider your application, a photocopy of your current Mississippi driver's license, or a driver's license from the state in which you reside, and any other documents required by this application.
5. **For reporters applying for Certification as a Certified Shorthand Reporter (In-State) OR for reporters applying for Temporary Permission as a Nonresident Court Reporter:** Obtain and enclose two (2) Statements of Reference, using the forms included with the application packet. These must be signed before a notary.

For reporters or students applying for Temporary Permission as a Noncertified Court Reporter: Obtain and enclose two (2) Statements of Reference **AND** Statement of Reference from the instructor which certifies that the applicant has successfully passed the speed of 200 words per minute multi-voice testimony (Q&A). Forms are included with the application packet. These must be signed before a notary.

6. Include a check for \$100 made payable to the Board of Certified Court Reporters.
7. Return application, Statements of Reference, and check to Board of Certified Court Reporters, Post Office Box 369, Jackson, MS 39205.
8. PLEASE KEEP A COPY OF YOUR ENTIRE APPLICATION PACKET.
9. ONLY AN ORIGINAL COMPLETED APPLICATION, STATEMENTS OF REFERENCE, AND AFFIDAVITS WILL BE ACCEPTED. INCOMPLETE APPLICATIONS WILL NOT BE CONSIDERED.
