

## Roster of Registered Spanish Language Court Interpreters

In Mississippi, a court interpreter is listed as “Registered” if the interpreter:

- (i) Completes an approved two-day (14 hour) ethics and skill-building workshop;
- (ii) Passes an approved criterion-referenced written examination with a minimum overall score of 80%;
- (iii) Agrees to be bound by the Code of Ethics for Mississippi Court Interpreters;
- (iv) Agrees to follow the Rules on Standards for Mississippi Court Interpreters;
- (v) Passes a criminal background check; and
- (vi) Executes the Interpreter Oath.
