The Clerk is further authorized and directed to begin exclusive use of the Mississippi Electronic Courts system (MEC) as the official system of case docketing in Madison County Chancery Court, and he is authorized and directed to maintain all case files as well as the Court's Minute Book, its Will Book, its Accountings Book, its Inventory Book, and its Guardians, Administrators and Executors Bonds, Oaths and Letters Book utilizing the said MEC.
