## New Features/ Enhancements

## Purpose

The purpose of this document is to notify court, attorney, and public users of the MEC system that several updates have been made. The changes made to the MEC system are detailed below.

## **Mobile Document Viewing**

#### All Users:

- PDF document files in MEC are now fully viewable from your iOS (iPad, iPhone) and Android mobile devices.
  - Prior to fix, only the first page of the document would display properly. Users could not scroll past the first page in multiple page documents. This has now been resolved.

## **Create Record on Appeal - Attachments**

#### **Docket Clerk Users:**

- The Create Record on Appeal checkbox/functionality has been modified to allow individual selection of attachments within Main Documents for inclusion/exclusion in creating the record on appeal.
  - Selected Page Number calculation has been updated to allow for selection/exclusion of individual attachments.

#### **Important Notes:**

- Once a selection is expanded using the "Attachments +/-" link, any documents selected must be selected from the expanded menu. Refreshing the screen (F5) will allow the user to clear all expanded menus and start over, if necessary.
- Individual attachments are disallowed from being sent to the MS Supreme Court electronically without the main document. Attachment selection was designed to be used in conjunction with creating the record on appeal, where attachments are merged into the record and one record file is transmitted.

## Create Record on Appeal – Record File Size Limitation

#### **Docket Clerk Users:**

• Docket clerk users should no longer receive an error when attempting to docket a record on appeal which exceeds a certain file size. Record on Appeal file size restrictions have been increased significantly.

### **Bug Fixes**

- Citation Search order of statutes/citations has been improved to allow courts to better locate citations when adding criminal counts.
- Docket Activity Report Some caseids were being reported twice in certain circumstances, causing errors on the generated report.
