

## **Circuit District Server – MEC Event Updates, Spring 2017:**

1. *Statement of Facts*
  - a. New event added to the Other Documents list (attorney & court filing). Event added because attorneys have been filing these using the “Miscellaneous Document” event.
2. *Appeal Opinion*
  - a. New event created based on upcoming electronic record transfer project. Added to the “Appeal Documents” list. Court only filing.
3. *Appeal Notice (not to be used for Notice of Appeal)*
  - a. New event created based on upcoming electronic record transfer project. Added to the “Appeal Documents” list. Court only filing.
4. *Subsequent Notice of Appeal*
  - a. E-filing access removed from attorney users. This filing requires a filing fee and should be filed conventionally. Event will remain on the “Appeal Documents” list for court users.
5. *Suggestion for Writ of Garnishment and Application for Writ of Garnishment:*
  - a. These events have been combined into one event: “Application/Suggestion for Writ of Garnishment” on the Complaints and Other Initiating Documents list.
    - i. Suggestion for Writ of Garnishment has been removed from the “Other Documents” list to prevent attorney e-filing. The combined event has been tweaked to be more user friendly and to add docket text to indicate the party being filed against. Court only filing (to help ensure attorneys pay the filing fee in order to file).
6. *Notice of Renewal of Judgment:*
  - a. New event added to the Complaints and Other Initiating Documents list. Court only filing (to help ensure attorneys pay the filing fee in order to file).
7. *Judgment Debtor Examination*
  - a. Removed from attorney filing list. Moved to Complaints and Other Initiating documents list. Court only filing (to help ensure attorneys pay the filing fee in order to file).
8. *Suggestion for Writ of Execution*
  - a. New event added to the Complaints and Other Initiating Documents list. Court only filing (to help ensure attorneys pay the filing fee in order to file).

Since the events noted in numbers 5 through 8 above cover the post judgment filings which require a filing fee, the following event removals have been made to further support the

requirement that attorneys make these filings conventionally (to help prevent them from using other events to get around the conventional filing requirement):

9. *Writ of Garnishment* (motion)

- a. This event has been removed from the motions list (to prevent attorney e-filing). This filing requires a filing fee, so attorneys will need to file these conventionally. Should be filed by clerks using the Application/Suggestion for Writ of Garnishment event.

10. *Suggestion for Writ*

- a. This event has been removed from the "Other Documents" list. It appears attorneys are using this event to file garnishments, but also some court users are using the event to file writ of garnishments. In order to standardize the writ of garnishment filing process, the Application/Suggestion for Writ of Garnishment event listed under Complaints and Other Initiation Documents should be used going forward (in order to have the "against" party language show up in the docket text). Since the other post judgment filing events are now being added, a generic writ event is no longer needed.
